Will the Minister of TEXTILES वस्त्र मंत्री  
be pleased to state :

- (a) whether the Government is planning to finance the setting up of the proposed seven PM MITRA Parks and if so, the details thereof along with the role of the State Governments in this process;
- (b) whether the Government is considering to establish such parks in other States of the country including the State of Rajasthan, Gujarat, Uttar Pradesh, Odisha, Haryana and Madhya Pradesh;
- (c) if so, the details thereof, district-wise;
- (d) the criteria followed by the Government in selecting sites for PM MITRA Parks; and
- (e) the number of textile parks functioned in the country and the benefits of establishing the Textile Parks along with the details of the estimated number of beneficiaries who are benefitted after setting up of these Textile Parks?

**(a) to (d):** The Government has approved setting up of 7 (Seven) PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks in Greenfield/Brownfield sites with world class infrastructure including plug and play facility with an outlay of Rs. 4,445 crores. 7 sites viz. Tamil Nadu (Virudhnagar), Telangana (Warangal), Gujarat (Navsari), Karnataka (Kalaburagi), Madhya Pradesh (Dhar), Uttar Pradesh (Lucknow), Maharashtra (Amravati) have been finalised for setting up these Parks.

The PM MITRA Scheme is proposed to be implemented through an SPV which will be a legal entity with 51% equity shareholding being held by the State Government. In addition, encumbrance-free land parcel of 1000+ acres and other facilitation in the shape of basic infrastructure and single window

clearance is being provided by the State Governments. The selection of sites under PM MITRA Scheme was done on a challenge method which considered relevant parameters such as good connectivity, adequate quality power infrastructure, water and waste water disposal systems, labour laws, Single Window Clearances, Stable and Conducive industrial/textile policy of the state, etc.

**(e):** Under the Scheme for Integrated Textile Parks (SITP), out of 54 textile parks sanctioned, 30 Textile parks have been completed, 22 Textile Parks are under completion. Once fully operational, all the above parks are expected to house about 5,193 textile units, generate employment for about 3,07,648 persons and attract investment of over Rs. 23,596 crores.
