Will the Minister of RAILWAYS be pleased to state:

- (a) the action taken so far for the construction of Silli Illoo bypass railway line in Ranchi Lok Sabha constituency and the time by which it is likely to be completed along with the details thereof;
- (b) the details of number of places in Ranchi where underpasses or rail over bridges are to be constructed by the Railways;
- (c) the details of places where affirmative action could not be taken due to the State Government;
- (d) the details of total revenues earned by Ranchi and Hatia railway stations from various items during the last one year; and
- (e) whether there is any proposal to start any new trains from Ranchi and Hatia and if so, the details thereof?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF UNSTARRED QUESTION NO. 491 BY SHRI SANJAY SETH TO BE ANSWERED IN LOK SABHA ON 06.12.2023REGARDING CONSTRUCTION OF SILLI ILLOO BYPASS RAILWAY LINE

(a): Final Location Survey for construction of Silli-Illoo Bypass Railway line avoiding Muri Junction (5.9 km) has been completed and Detailed Project Report (DPR) has been prepared. At present, the project is not sanctioned, as such, no completion time can be fixed at this stage.

(b): 06 Nos. Road Over Bridges (ROBs), (out of which 3 ROBs for rebuilding) and 12 Nos. Road Under Bridges (RUBs)/Limited Height Subway (LHS) have been sanctioned in Ranchi Constituency, which are at various stages of planning, estimation and execution.

(c): Details of such places are as under:

ROBs

ROB in lieu of LC No MH-29 at Km 417/33-35 between Namkom-Ranchi station near Chutia Power House at Ranchi - Alignment is yet to be finalised by the State Govt.

ROB in lieu of LC No. RL-5 at Nayasarai between Ranchi-Piska -Railway portion completed and approaches yet to be taken up by State Govt.

Underpasses

Additional vent in existing RUB near Meccon Colony in lieu of LC No. MH-33 - Railway portion completed and approaches yet to be taken up by State Govt. (d): Total revenue earned by Ranchi and Hatia railway stations from various items during the last one year are ₹45,25,44,543/- and ₹30,64,29,738/- respectively.

(e): Ranchi and Hatia are presently being served by 104 and 52 train services respectively including the recently introduced service of 20897/20898 Howrah-Ranchi Vande Bharat Express (w.e.f 27.09.2023), 18617/18618 Ranchi-New Giridih Express (w.e.f 12.09.2023) and 22349/22350 Patna-Ranchi Vande Bharat Express (w.e.f 27.06.2023). Besides, introduction of new train services is an ongoing process on Indian Railways subject to operational feasibility, traffic justification, availability of resources, etc.
