**Land Acquired for Coal Mining in Jharkhand**

506. SHRI SUNIL KUMAR SINGH:

Will the Minister of COAL be pleased to state:

- (a) the details of the number of villages in Jharkhand where land has been acquired by the Central Undertaking of the Government of India such as Amarpali-Magadh Project, CCL etc.;
- (b) the village-wise area of land (tenant, Government and forest land) is proposed to be acquired and the area of land acquired so far;
- (c ) the area of land where excavation work is currently being done by CCL; and
- (d) the village-wise details of lands acquired, compensation fixed under RFCTLRR Act, 2013?

(c ): Total area in Magadh Project where excavation work is currently being done is 583.15 Acres (236 Hectare). Total area in Amrapali Project where excavation work is currently being done is 1313.70 Acres (531.64 Hectare).

(d): The village wise acquisition details of land acquired under CBA (A&D) Act are given in point (a). Compensation for the acquired land has not been assessed under RFCTLARR Act. Tenants have opted for compensation under agreement rate of Rs. 902900.00 per Acre (with a provision of one permanent employment to the nominee of land losers against 2 Acres of offered land) in line with CIL R&R Policy.
