## CHALLENGES FACED BY TEXTILE INDUSTRY

### 615. SHRI RAJENDRA DHEDYA GAVIT:

Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

(a) the details of the challenges being faced by the exporters, manufacturers and workers of the textile industry in the country;

(b) whether the Government has provided any financial or non-financial support to assist textile business during recession;

(c) if so, the details thereof and if not, the reasons therefor;

(d) whether the Government has introduced any program and initiative to enhance the skills of the workforce in the textile sector and if so, the details of programs undertaken during the last two years, State/UT-wise; and

(e) if not, the reasons therefor?

### ANSWER वस्त्र राज्य मंत्री (**श्रीमती दर्शना जरदोश**) THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

(a) to (c): The Government of India is implementing a number of schemes / initiatives to address various challenges faced by the textile sector. The Government is implementing various schemes namely Prime Minister Mega Integrated Textile Regions and Apparel (PM MITRA) to boost infrastructure development in textile sector, Production Linked Incentive (PLI) Scheme with an aim to increase the exports, Samarth – the Scheme for Capacity Building in Textile Sector, National Technical Textiles Mission (NTTM) to promote research and development environment in Textiles sector, TUFS to augment the textiles machinery, Silk Samagra-2 to have inclusive sericulture value chain development, Raw Material Supply Scheme (RMSS) to ensure availability of raw material, National Handloom Development Program (NHDP), and National Handicraft Development Program (NHDP) for promoting cultural heritage and welfare of artisans and weavers for development of textile sector and enhancing the productivity.

(d) to (e): The Government with a view to enhance the skills of the workforce in the textile sector has formulated Samarth Scheme under a broad skilling policy framework. The scheme aims to provide demand driven and placement oriented National Skill Qualification Framework (NSQF) compliant skilling programmes to incentivize and supplement the efforts of the industry in creating jobs in the organised textile sector (excluding spinning & weaving) and to provide skilling and skill-upgradation in the traditional textile sectors.
