### PRICES OF HANK YARN

Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

- (a) whether the Government has taken cognizance of the fluctuation of Hank Yarn prices between 30th June 2020 to 31st October 2023;
- (b) if so, the details of the action taken by the Government to control the Hank Yarn prices and ensure its affordability and if not, the reasons therefor;
- (c) the details of export and import of the Cone Yarn/Hank Yarn, Handloom fabric and the value of the products during the last five years;
- (d) the details of the usage of Hank Yarn of Cotton/Silk/Jute/Wool in the domestic market;
- (e) the details of the total production of Hank yarn in India and the percentage of total yarn production of the spinning mills in India;
- (f) whether the Government has any plans to implement special package to develop/improve the handloom sector in India on par with MSME sector;
- (g) whether the Government is aware of variety-wise per capita utilization and availability of handloom fabric in accordance with Textile Committee Report; and
- (h) if so, the details thereof and if not, the reasons therefor?

- (a) & (b): No fluctuation in hank yarn prices between 30<sup>th</sup> June 2020 and 31<sup>st</sup> October 2023 has been reported.
- (c): As per data extracted from DGCI&S portal, Kolkata, the details of export & import of cotton yarn and handloom fabrics during the last five years from 2018-2019 to 2022-2023 and current year 2023-2024 (up to September) are at **Annexure I.**

As per the data compiled from the statutory return submitted by units to the Office of the Textile Commissioner, Hank yarn exported out of India during last five years from 2018-2019 to 2022-2023 and current year 2023-2024 (up to September) is given below:

- (d): Hank yarn is used for production of handloom products which are broadly, Saree, Dhoti, Towel & Gamcha, Angavastram, Lungi, Bed-sheet and related items, Durries, dress material, blankets, shawls, etc.

- (f): The Ministry of Textiles is administering the schemes of National Handloom Development Programme and Raw Material Supply Scheme. Under the National Handloom Development Programme, clusters are identified and financially assisted through various interventions like provision of upgraded looms & accessories, solar lighting units, construction of workshed, product & design development, technical and common infrastructure, marketing of handloom products in domestic/overseas markets, concessional loans under MUDRA Scheme, social security for the beneficiaries, etc. Under the Raw Material Supply Scheme, the Ministry provides transport subsidy, for transportation of yarn to the doorstep of the beneficiary, and 15% Price Subsidy on Cotton Hank Yarn, Domestic Silk, Woollen and Linen yarn and blended yarn of natural fibres. E-Commerce portal has been developed to enable the weavers to sell their product online while eliminating intermediaries.
- (g) & (h): Textiles Committee publishes 'Market for Textiles & Clothing –National Household Survey' which estimates the per capita & aggregate demand of textiles and apparels in the country by region, gender, area, income group etc. in the household sector in addition to the estimation of the preference pattern by fibre, product groups viz. woven apparels, knitted apparels, home textiles etc. The per capita purchases of textiles by Handloom Sector is as under:
