PROMOTION OF AIR TRAVEL

738. SHRI BALAK NATH Will the Minister of CIVIL AVIATION

be pleased to state:-

- (a) the new sectors which have been identified by the Government to promote air travel in the country during the last three years;
- (b) whether private and public sector service providers have been permitted to provide air services in the said identified sectors and if so, the details thereof;
- (c) whether any increase in number of air passengers have been noticed by the Government during the last three years and if so, the details thereof; and
- (d) whether the Government expects any increase in the number of air passengers by 2024 and if so, the details thereof?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

- (a): Under Regional Connectivity Scheme (RCS) Ude Desh ka Aam Nagrik (UDAN), 517 routes have been operationalised connecting 76 Airports since its' inception. Year-wise breakup of RCS airports and routes operationalised in the last 3 years are available at Annexure-I & II.
- (b): Under the UDAN scheme, both private and public sector entities are involved in providing air services. Private airlines viz. Indigo, Spicejet, Star Air, Heritage Aviation, Air Taxi, Fly Big, IndiaOne Air and Public sector operators namely, Alliance Air and Pawan Hans Ltd. operate the flights.;

(c) & (d): The details of passenger growth during last three years are at Annexure-III. India is one of the fastest growing aviation markets in the world. As per the trends during the last three years the number of air passengers is likely to increase during the year 2024.
