Will the Minister of CIVIL AVIATION

be pleased to state:-

- (a) the details of airports identified and developed under UDAN Scheme across Jharkhand including Ranchi;**
- (b) the details of expenditure incurred under various heads for the development of Ranchi Airport during the last two years;**
- (c) the details of work undertaken during the last two years under CSR head at Ranchi Airport along with the amount spent thereon; and**
- (d) the steps taken so far by his Ministry on the suggestions given by Airport consultative Committee during the last one year?**

ANSWER

(a) Six airports ,namely, Bokaro, Dumka, Jamshedpur, Hazaribagh, Deoghar and Daltonganj have been identified for development and operation of RCS flights in the State of Jharkhand. The airports at Jamshedpur and Deoghar have been operationalised. The development work at Bokaro and Dumka airports have been completed and their licensing is under process. In case of Hazaribagh, land is yet to be provided by the State Government for development of airport. The development work of the airport at Daltonganj is at planning stage.

(b): The details of capital expenditure under various heads, incurred for the development of Ranchi Airport by Airports Authority of India (AAI) during the last two years is at Annexure I;

(c) Amounts of Rs.8.00 Cr. and Rs.6.00 Cr were spent during the years 2022-23 and 2023-24 respectively for setting up of central kitchen at Hazaribagh through Akshay Patra Foundation.

(d) There is no Airport Consultative Committee at Ranchi airport. The action taken in respect of Airport Advisory Committee (AAC) meeting held during last one year at Ranchi Airport is attached as Annexure II.

Action taken report on Airport Advisory Committee(AAC) Meeting at Ranchi Airport held during last one year

Action taken report on AAC meeting held at Ranchi Airport on 01.06.2023.

I. हवाईअड्डो सेवाओं को यात्रियों के लिये ज्यादा सुविधाजनक बनाना -

Action Taken: Provision of Medical Emergency Room with Doctors has been made and a new Executive lounge for passengers is ready and will be operationalised after BCAS approval.

II. यातायात प्रबन्धन एवं जाम की समस्या -

Action Taken ; Instruction given by Chairman, AAC to SSP, Ranchi to smoothen traffic pattern near Airport, Entrance and Exit to the Terminal Building is being modified for better passenger facilitation.

III. हवाई सम्पर्क सेवा का विस्तारीकरण -

Action Taken ; During the meeting all concerned Airlines were requested to explore the possibilities to provide air connectivity to new destinations. However, Airlines plan their flight on specific route as per demand, commercial feasibility and policy of the airlines.

IV. एयर कार्गो के प्रचार - प्रसार की व्यवस्था-

Cold storage having capacity of 2 Metric Tonne and 02 Strong Room has been constructed and put in use.
