IRRIGATION PROJECTS IN ODISHA

777. SHRI JUAL ORAM

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details and the number of medium, multipurpose and major projects to be executed in the State of Odisha which are pending for the approval of Central Water Commission;
- (b) the total hectares of land that would be brought under irrigation once each of those projects are completed;
- (c) the estimated cost of those projects;
- (d) the funds earmarked for those projects and funds released so far;
- (e) the steps taken to expedite the clearance; and
- (f) the present status of each of those projects?

(a) to(c) & (f) There are 5 number of medium irrigation projects. 1 number multipurpose (major) project, and 2 major irrigation projects presently under appraisal at Central Water Commission (CWC). Details in this regard are tabulated below.

- (d) One of the pre-requisites for inclusion of any major/ medium/ multipurpose irrigation project for financial assistance under any of the ongoing schemes of this Ministry, requires the project to be appraised by CWC. Since the above projects are still under appraisal, no funds have been earmarked / released for those projects at this stage.
- (e) All projects to be appraised in CWC are to be submitted through online platform, namely, ePAMS. The platform allows real-time monitoring of the appraisal process for each of the projects under appraisal at CWC. Further, in the updated guidelines issued in the year 2017, CWC has laid down indicative timelines for the appraisal process. This enables measuring of delays against the laid down benchmark.
