- (a) whether two projects for water supply, one project for sewage and septage management, two projects for drainage and three projects for development of parks have been sanctioned for Machilipatnam city in Andhra Pradesh under AMRUT with an estimated cost of Rs. 80 crores;**
- (b) if so, the details thereof;**
- (c) whether the projects have been completed and become operational; and**
- (d) if so, the details thereof and if not, the reasons for delay along with the time by which these are likely to be completed?**

(a) to (c): Yes Sir, under Atal Mission for Rejuvenation Urban Transformation (AMRUT), 02 projects for water supply, 01 project for sewage

and septage management, 02 projects for drainage and 03 projects for development of parks have been undertaken in Machilipatnam city in Andhra Pradesh with an estimated cost of ₹80 crore. As reported by the State, out of the 8 projects, 4 projects have been completed and are operational. The remaining 4 projects are under implementation. The present status of the above projects is at ANNEXURE.

(d): As per the response from the state, the delay in the completion of the 4 projects is mainly due to COVID 19. The likely date of completion of these projects as indicated by the State is as per table below.
