- (a) Whether the rehabilitation and upgradation work of National Highway (NH-730-C) from Farrukhabad-Allahganj-Jalalabad-Madnapur-Katra-Khudaganj to Pilibhit, passing through Shahjahanpur Parliamentary Constituency of Uttar Pradesh is being carried out along with two laning and paved shelter configuration in Allahganj to Miranpur Katra Section;
- (b) if so, the details thereof;
- (c) Whether the Government has received representations for investigation by Central Technical Committee regarding alleged malpractices and quality of material in the construction of the said NH; and
- (d) If so, the action taken/proposed to be taken in this regard?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS (SHRI NITIN JAIRAM GADKARI)

(a) to (b) Yes Sir, the work of rehabilitation and upgradation to two lane and paved shoulder of National Highway 730-C from Farrukhabad-Allahganj-Jalalabad-Madnapur-Katra-Khudaganj to Pilibhit in the state of Uttar Pradesh, totaling to 183 km in four packages, has been taken up under Green National Highways Corridor Project (GNHCP) with loan

assistance of World Bank on Engineering, Procurement, and Construction (EPC) mode. The details are placed at Annexure.

(c) to (d) Yes Sir, the Government received a representation from the public representative regarding quality issues of works on this road section. An independent expert for quality audit was appointed to investigate the alleged irregularities in the construction and quality of the construction. Report has been submitted by the auditor to Ministry, wherein it is concluded that overall executed construction works are found satisfactory.
