SUBSIDIES FOR ROOFTOP OF HOUSES

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Government has given concessions/subsidies for installation of solar panel on the rooftop of Houses
- (b) if so, the details thereof till date, State-wise
- (c) whether some States have requested the Union Government to exempt them from sharing the cost of such projects and also asked to grant complete subsidy/concession
- (d) if so, the details thereof and the action taken thereon?

ANSWER

THE MINISTER OF NEW & RENEWABLE ENERGY AND POWER

(a) & (b)The Ministry of New and Renewable Energy (MNRE) is implementing Rooftop Solar (RTS) Programme Phase-II, wherein, Central Financial Assistance (CFA) is being provided for installation of RTS in residential sector. The CFA admissible for general category states is Rs. 14588/kW for first 3 kW RTS capacity and Rs. 7294/kW for RTS capacity beyond 3 kW and upto 10 kW. For special category states (North-eastern states including Sikkim, Uttarakhand, Himachal Pradesh, UT of Jammu & Kashmir, Ladakh, Lakshadweep, and Andaman & Nicobar Islands), the admissible CFA is Rs. 17662/kW for first 3 kW RTS capacity and Rs. 8831/kW for RTS capacity beyond 3 kW and upto 10 kW. The Resident Welfare Associations/ Group Housing Societies (RWA/GHS) are also eligible to avail CFA for RTS installation in common facilities, upto a maximum of 500 kW capacity. The CFA admissible for RWA/GHS is Rs. 7294/kW in general category states and Rs. 8831/kW in special category states. The State/UT wise details of the CFA released under the programme, is attached as **Annexure**.

(c)&(d)Under Rooftop Solar Phase-II programme, States/UTs are not obligated to provide any subsidy for rooftop solar projects. However they are at liberty to provide any subsidy/CFA which they used for such projects in addition to MNRE's CFA.
