**EXTENSION OF TIME FOR PROJECTS**

**NO. 885 DR. SANJAY JAISWAL:**

**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) whether the Government proposes to extend time for several projects under the Smart Cities Mission (SCM);**
- (b) if so, the details thereof, State and district-wise;**
- (c) the reasons for inordinate delay in completion of the said projects under SCM; and**
- (d) the details of funds released by the Government and the quantum of funds utilised by the respective cities under SCM?**

**(a) to (d) : Government of India launched Smart Cities Mission (SCM) on 25 June 2015. 100 Smart Cities have been selected through 4 rounds of competition from January 2016 to June 2018.**

**As on 24 November 2023, work orders have been issued in 7,960 projects worth around ₹ 1,71,237 crore; of which 6,271 projects worth ₹ 1,16,269 crore(68%) have been completed. As on 24 November 2023, under SCM, ₹ 78,749.88 crore has been released; of which ₹ 71,135.70 crore (90%) has been utilized. The State/UT/Smart City-wise details of funds released/utilized & the progress of projects under SCM is given in Annexure-I.**

**The period of implementation of SCM has already been extended upto June 2024 and all Smart Cities are expected to complete their projects within the stipulated time.**
