LOSSES INCURRED IN TOLL COLLECTION

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

be pleased to state:

- (a) the details of estimated losses incurred in the income from Toll collection since the Covid-19 pandemic, month-wise;
- (b) the period for which Toll collection was suspended during the Covid-19 pandemic;
- (c) the details of measures taken to minimize/compensate the said incurred loss;
- (d) the details of the Toll tax collected during Covid period and thereafter till date;
- (e) the number of days for which Toll plazas on various National Highways remained non-functional due to protests during the said period;
- (f) the estimated loss of income as a result thereof; and
- (g) whether the Government has compiled Toll and State-wise data of the same and if so, the details thereof?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

(a) The user fee (Toll) collection is done through user fee (toll) collection agency and remittance is fixed as per terms of the Contract in case of

Public Funded Fee Plazas. However, in case of Force Majeure events such as Flood, Earthquake, Pandemic etc the agency is granted relief towards forgone remittance as per stipulations of Contract Agreement. Forgone remittance/relief is as per contractual obligations.

- (b) The user fee collection was suspended during complete lockdown from 26.03.2020 (09:00 hrs) to 19.04.2020 (24:00hrs) i.e. for a period of 24.625 days.
- (c) NHAI had issued policy guidelines dated 28.05.2020 for giving relief under Force Majeure conditions due to COVID Wave-1 for public funded projects.
- (d) The details of User fee collection during COVID Period and thereafter from NHAI's fee plazas is as under:
