†*12. SHRI GAJANAN KIRTIKAR:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the total number of ASHA workers in the country, State/UT-wise;
- (b) the total amount paid as remuneration/ honorarium to ASHA workers in various districts of the country including Maharashtra during the last five years;
- (c) whether the salary paid to ASHA workers is much lower than the minimum salary of peons as per the recommendation of the 7th Pay Commission;
- (d) the steps taken by the Government to increase the minimum salary of ASHA workers:
- (e) whether any amount of honorarium to be paid to ASHA workers is pending with Government and if so, the details thereof, State/UT-wise including Maharashtra; and
- (f) the total increase in the compensation paid to ASHA workers during the said period?

ANSWER THE MINISTER OF HEALTH AND FAMILY WELFARE (DR MANSUKH MANDAVIYA)

(a) to (f) A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED QUESTION NO. 12 FOR 2ND FEBRUARY, 2024

- (a) As per NHM-MIS report (as on 30.09.2023), State-wise details of total number of ASHAs under National Health Mission (NHM), except Goa & Chandigarh, is placed at **Annexure-I**.
- (b) to (d): ASHAs are envisaged to be community health volunteer and are given performance-based incentives after completion of specific activities under various National Health Programmes.

The activities for which incentives are paid to ASHAs are expanded from time to time. ASHAs incentive can be divided into two parts;

• Monetary Incentives – ASHAs receive a monthly incentive of Rs. 2000/month for routine and recurring activities from the Central Government. Additionally, ASHAs are provided with performance-based incentives for a varied set of activities under various National Health Programmes. Further, States/UTs in their Programme Implementation Plans (PIPs) have also been given flexibility to provide a range of monetary incentives to the ASHAs. The details of these ASHA incentives are available on the following Uniform Resource Locator (URL):

After the launch of Ayushman Arogya Mandir, ASHAs are eligible additionally for Team Based Incentives (TBIs) along with ANMs based on monitored performance indicators (up to Rs. 1000 per month).

• **Non-Monetary Incentives** - ASHAs are also entitled to non-monetary incentives like – ASHA Uniform, Identity Card, Cycle, Mobile, CUG Sim, ASHA Diary, Drug Kit, ASHA Award, ASHA rest room etc.

Further, in the year 2018, the ASHA Benefit Package was introduced by the Govt. of India acknowledging the significant contribution and commitment of ASHAs. It included the following components—

- a) Doubling of routine and recurring incentives amount from Rs. 1000 per month to Rs. 2000 per month.
- b) Extending social security benefits of Life insurance, accident insurance and pension to all eligible ASHAs through enrolment in following schemes –
- Pradhan Mantri Jeevan Jyoti Beema Yojana (PMJJBY) with a benefit Rs. 2.00 Lakh in case of death of the insured (annual premium contributed by GOI).

• Pradhan Mantri Suraksha Beema Yojana (PMSBY) with a benefit of Rs.2.00 lakh for accidental death or permanent disability; Rs. 1.00 lakh for partial disability (annual premium contributed by GOI).

In addition, Pradhan Mantri Shram Yogi Maan Dhan (PM-SYM) with pension benefit of Rs. 3,000/- pm after age of 60 years (50% contribution of premium by GOI and 50% by beneficiaries) is also available for ASHA workers. ASHAs across the States/UTs have been enrolled in all the above mentioned Social Security Schemes as per the defined eligibility norms.

In addition to the above incentives, as an acknowledgement of her service, significant contribution and commitment, a cash incentive of Rs. 20,000/- under NHM and a citation by the State/UT is given to ASHAs, who leave or opt to leave the programme after a minimum of 10 years of service.

The expenditure for ASHA incentive under National Health Mission for the Financial Years during the last five years viz. from 2018-19 to 2022-23 against Central release, State release & unspent balances (at the beginning of the year) as per Financial Monitoring Reports (FMRs) submitted by all States/UTs including Maharashtra is at **Annexure-II**.

- (e) Under the National Health Mission, financial and technical support is provided to the States/UTs for strengthening the healthcare systems including incentives to ASHA workers, based on the proposals received from the States/UTs in their Annual Programme Implementation Plan (PIP) and subject to the Resource Envelope (RE). Further, the funds are released to States/UTs on a lump sum basis as per the request from the State/UTs.
- (f) The details of increase of performance-based incentives for a varied set of activities under various National Health Programmes since 2019 to ASHA workers is at **Annexure-III**.
