(a): The Department of School Education and Literacy is implementing an Integrated Centrally Sponsored Scheme for School Education- Samagra Shiksha w.e.f. 2018-19, which subsumes the three erstwhile Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE). The details of the fund released and expenditure incurred under Samagra Shiksha Abhiyan (SSA) in Haryana during each of the last four financial years is given below:

(c) & (d): The Cabinet has approved a new Centrally Sponsored Scheme named Pradhan Mantri Schools for Rising India (PM SHRI) on 7th September, 2022. These schools are to showcase the implementation of the National Education Policy 2020 and emerge as exemplar schools over a period of time, and also offer leadership to other schools in the neighbourhood. Under the scheme, there is a provision of setting up of more than 14500 PM SHRI Schools by strengthening the existing schools from amongst schools managed by Central government/State/UT Government/local bodies. 31 States/UTs/KVS/NVS have signed the Memorandum of Understanding (MoU) including the state of Haryana. In the first phase of selection of PM SHRI Schools a total of 124 PM SHRI Schools have been selected from the state of Haryana.

The major interventions in the PM SHRI Scheme used for modern, transformation and holistic method of imparting education are:

- i. Quality and Innovation (Learning Enhancement Programme, Holistic Progress Card, Innovative Pedagogies, Bagless days, Internships with Local artisans, Capacity building etc.)
- ii. Beneficiary oriented Entitlements under Right to Education (RTE) Act.
- iii. Annual School Grants (Composite School grants, Library grant, Sports grant)
- iv. Early Childhood Care and Education including Balvatika and Foundational Literacy and Numeracy
- v. Equity and Inclusion including provision of safe and appropriate infrastructure for girls and children with special needs (CwSN).
- vi. Encouraging flexibility in choice of subjects offered to students.
- vii. Encouraging mother tongue as medium of instruction using technological interventions to help bridge language barriers between teachers and students.
- viii. ICT, smart classrooms and digital libraries for using digital pedagogy.
- ix. Strengthening of existing infrastructure
- x. Vocational interventions & Enhancing internship/entrepreneurship opportunities especially with local industry. Mapping of skills with developmental projects/nearby industry and develop courses/curriculum accordingly
