# GOVERNMENT OF INDIA MINISTRY OF MINORITY AFFAIRS LOK SABHA UNSTARRED QUESTION NO. 1000 ANSWERED ON 08.02.2024

### **FUNDS UNDER PMJVK**

#### 1000. SHRI. RAJENDRA AGRAWAL:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) the quantum of funds released under Pradhan Mantri Jan Vikas Karyakaram (PMJVK) and date of its distribution during the last three years, State and year-wise;
- (b) the details of the number of minority concentration areas covered under PMJVK;
- (c) the land acquired under PMJVK for construction of projects in the said areas and the classification thereof;
- (d) the number of projects under construction and their dates of commencement under PMJVK, particularly in the State of Uttar Pradesh;
- (e) the details of total number of health Anganwadi Centres available with free equipments and safe drinking water facility provided to girls students under PMJVK during the year 2022-23, State-wise;
- (f) whether any progress report on the achievements under the scheme has been prepared by the Government during the said period; and
- (g) if so, details thereof?

## ANSWER

## THE MINISTER OF MINORITY AFFAIRS (SHRIMATI SMRITI ZUBIN IRANI)

(a) The Government implements various schemes for the welfare and upliftment of every strata, including minorities, specially the economically weaker and lesser privileged sections of the society, through various schemes of the Ministry of Skill Development and Entrepreneurship, Ministry of Textiles, Ministry of Culture, Ministry of Women and Child Development and Ministry of Rural Development. Ministry of Minority Affairs specifically implements various schemes across the country for socio-economic and educational empowerment of the six (6) Centrally notified minority communities.

Pradhan Mantri Jan Vikas Karyakram (PMJVK), a Centrally Sponsored Scheme (CSS), is an area development programme with an aim to develop community infrastructure and basic amenities in the minority concentrated areas on the fund sharing basis between the Government of India and the respective State/Union Territory. The State-wise and year-wise details of funds released during the last three years under PMJVK is given at annexure-I.

(b) & (c) The scheme was earlier implemented as Multi-sectoral Development Programme (MsDP), which was restructured and implemented as Pradhan Mantri Jan Vikas Karyakram (PMJVK) with effect from May, 2018, in 1300 identified blocks, towns and district headquarters of the country. The list of these 1300 identified blocks, towns and district headquarters is available on the website of this Ministry i.e. www.minorityaffairs.gov.in. The scheme has now been revised with effect from financial year 2022-23, for implementation in all districts of the country during the period of 15th Finance Commission Cycle. The States/UTs can proposed projects under PMJVK which are in a location in the district where the minority population is 25% or more in the catchment area of 15 KM radius.

As per the PMJVK guidelines, the land for construction of infrastructure in the identified areas are provided by State/ UT. No land cost is provided under PMJVK.

- (d) The details of the projects approved and being executed under PMJVK during the last three years across the country including the State of Uttar Pradesh are given at annexure-II.
- (e) The State-wise details of Anganwadis centres approved during the last three year under the PMJVK are as under:-

(f) & (g) An evaluation study of PMJVK was conducted by the NITI Aayog in the year 2020-2021, observed that the scheme was helpful in bridging the development deficit in the identified areas of the country and had contributed in upgradation of school infrastructure, providing additional classrooms, new hostels, Community Health Centres (CHCs), Primary Health Centres (PHCs), Industrial Training Institutes (ITIs), polytechnics, skill training centres, etc. The restructuring of the programme in the year 2018-19 has brought in significant improvement with a greater focus on women-centric projects. It was, inter alia, recommended by the NITI Aayog to increase coverage of the scheme, to ensure that projects should reach the minority communities across all States/ UTs.
