### MSMEs RUN BY WOMEN

1030. SHRIMATI MALA ROY:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details and the number of registered Micro, Small and Medium Enterprises (MSMEs) being run by the women entrepreneurs in the country along with the loans disbursed under various schemes to women-led MSMEs in the country, State-wise;
- (b) the details of pending loan applications submitted by women led enterprises in West Bengal during the last three years including total applications received and disbursement and repayment status thereof; and
- (c) whether the Government has any proposal to clear all applications for MSMEs by March 2024 and if so, the details thereof?

- (a) & (b): The State/UTs —wise details of women-owned Micro, Small and Medium Enterprises (MSMEs) registered on Udyam Portal and Udyam Assist Platform in the country are attached at **Annexure I**. The State/UTs-wise details of assistance extended under Credit Guarantee Scheme for Micro and Small Enterprises and Prime Minister's Employment Generation Programme (PMEGP) to women-owned MSMEs, in the country, including the State of West Bengal are attached at **Annexure II** and **Annexure III**, respectively.
- (c): As informed by RBI, vide circular FIDD. MSME & NFS.BC.No 60/06.02.31/2015-16 dated August 27, 2015 on 'Streamlining flow of credit to Micro and Small Enterprises (MSEs)' for facilitating timely and adequate credit flow during their 'Life Cycle', banks have been advised to clearly delineate the procedure for disposal of loan proposals, with appropriate timelines, and to institute a suitable monitoring mechanism for reviewing applications pending beyond the specified period, without any compromise on due diligence requirements.
