Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government is implementing PM Awas Yojana-Urban (PMAY-U) and Gramin in order to provide proper housing to the homeless people in the urban and rural areas of the country;
- (b) if so, the current status thereof, State-wise and the amount provided as subsidy to each beneficiary for a house in urban and rural areas under the scheme;
- (c) whether the subsidy for construction of a house is lower in rural areas in comparison to urban areas and if so, the reasons therefor;
- (d) the steps being taken by the Government to provide uniform subsidy for construction of house in both urban and rural areas;
- (e) whether the Government is aware that rural population has to depend on cities due to easy availability of construction material in cities;
- (f) if so, whether the Government proposes to raise the subsidy for the eligible beneficiaries of the scheme in view of the rising prices of construction material and labour; and
- (g) if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS

(SHRI KAUSHAL KISHORE)

(a) to (d): Yes, Sir. Ministry of Housing and Urban Affairs (MoHUA) is implementing Pradhan Mantri Awas Yojana - Urban (PMAY-U) - 'Housing for All' Mission since June 25, 2015 to provide pucca house with basic amenities to all eligible urban beneficiaries across the country including homeless people of the country. The scheme is

implemented through four verticals i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), In-Situ Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS).

MoHUA is providing its fixed share as Central Assistance of ₹1.0 lakh under ISSR, ₹1.5 lakh for AHP and BLC verticals under PMAY-U. Under CLSS vertical of the scheme, an interest subsidy at the rate of 6.5% which amounts up to ₹2.67 lakh per house, was provided for beneficiaries of Economically Weaker Sections (EWS) and Low Income Group (LIG) category.

As on 29.01.2024, a total of 118.63 lakh houses have been sanctioned by the Ministry based on the project proposals submitted by States/Union Territories (UTs) under PMAY-U, out of which 114.01 lakh have been grounded and 80.02 lakh are completed/delivered to the beneficiaries in urban areas. The State-wise details of houses sanctioned, grounded and completed under PMAY-U is at Annexure-I.

In order to achieve the target of 'Housing for All' in rural areas, Ministry of Rural Development (MoRD) is implementing Pradhan Mantri Awaas Yojana - Gramin (PMAY-G) with effect from 1st April 2016 to provide assistance to construct 2.95 crore pucca houses with basic amenities by March 2024. Out of the overall target of 2.95 crore houses allocated to States/UTs under PMAY-G, more than 2.94 crore houses have already been sanctioned to the beneficiaries and over 2.55 crore houses have already been completed as on 02.02.2024.

Under PMAY-G, beneficiaries are provided financial Assistance of ₹1.20 lakh in plain areas and ₹1.30 lakh in hilly States (including North Eastern States and UTs of Jammu & Kashmir and Ladakh), difficult areas and Integrated Action Plan (IAP) districts. Additional Assistance of ₹12,000/- is extended for construction of toilets through convergence with Swachh Bharat Mission – Gramin (SBM-G), Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) or any other dedicated source of funding. Further, it is mandatory to provide support of 90/95 person days unskilled wage employment at the current rates to a PMAY-G beneficiary for construction of his/her house in convergence with MGNREGS. The

PMAY-G households are also provided water, LPG, and electricity connections in convergence with other relevant schemes. The State/UT-wise details of targets allocated, houses sanctioned to eligible beneficiaries and houses completed under PMAY-G as on 02.02.2024 is at Annexure-II.

(e) to (g): As per the PMAY-U guidelines, a fixed amount of Central Assistance is provided to the beneficiaries under PMAY-U. The remaining cost of the house as per Detailed Project Report (DPR) is shared by States/UTs/Urban Local Bodies (ULBs)/Beneficiaries. Based on the requests received from the States/UTs, PMAY-U period, which was up to 31st March 2022 earlier, has been extended till 31.12.2024, except CLSS vertical of the scheme, to complete all the houses sanctioned without changing the funding pattern and implementation methodology. The Ministry is not contemplating any change in the Central Assistance at this stage of the scheme.

The unit assistance provided to beneficiaries under PMAY-G is as per the approval of the Union Cabinet and at present, there is no proposal under consideration in the Ministry of Rural Development for upward revision of unit assistance under PMAY-G.
