# LOK SABHA UNSTARRED QUESTION NO. 107 TO BE ANSWERED ON 02.02.2024

# ANGANWADI CENTRES IN MADHYA PRADESH

107 DR. DHAL SINGH BISEN:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of Anganwadi centres (AWCs) and the children enrolled in these centresin Madhya Pradesh, district-wise;
- (b) the details of remuneration proposed to be increased for Anganwadi Workers and Helpers in view of the price-rise and less salary being paid to them State/UT-wise including Madhya Pradesh;
- (c) the number of AWCs which have pucca building, drinking water and toilet facilities, State/UT-wise including Madhya Pradesh and the number of AWCs which have no building, district-wise;
- (d) the details of the quantity of Rice, Lentils, Cereals, Oil, Vegetables, Sugar, Iodized salt etc. prescribed for each children, State/UT-wise including the above said State; and
- (e) the details of the quantity and quality of food being supplied to child enrolled in AWCs, State/UT-wise including Madhya Pradesh along with the steps taken to ensure supply of good quality food to them, State/UT-wise including the above said State?

# ANSWER

# MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) District wise number of Anganwadi Centres (AWCs) in the State of Madhya Pradesh and the children enrolled in these AWCs is at **Annexure I**.

(b) Government of India increases the honorarium of AWWs/AWHs from time to time. From 1<sup>st</sup> October, 2018, Government of India has enhanced the honorarium of AWWs at main-AWCs from Rs. 3,000/- to Rs. 4,500/- per month; AWWs at mini- AWCs from Rs. 2,250/- to Rs. 3,500/- per month; AWHs from Rs. 1,500/- to Rs. 2,250/- per month; and introduced performance linked incentive of Rs.250/- per month for AWHs and Rs.500/- to AWWs. In addition, States/UTs are also paying additional monetary incentives/honorarium to these functionaries from their own resources which vary from State to State. The additional honorarium provided by the States/UTs is placed at **Annexure II**. At present no proposal is under consideration to increase the honorarium of AWWs/AWHs.

(c) Every Anganwadi Centre is being operated in a building. State/UT wise details of infrastructure (drinking water and toilet facilities) of operational Anganwadi Centres (AWCs) is at **Annexure III**.

(d) and (e) Under Supplementary Nutrition Programme, food grains (Wheat/Rice/Coarse grains) are provided to beneficiaries at Anganwadi Centres as per the prescribed nutritional norms through Department of Food & Public Distribution (Ministry of Consumer Affairs, Food & Public Distribution) including State of Madhya Pradesh under Wheat Based Nutrition Programme (WBNP) and Scheme for Adolescent Girls (SAG).

Further, greater emphasis is being given on the use of millets for preparation of Hot Cooked Meal and Take Home Rations (THR- not raw ration) at Anganwadi centres for beneficiaries including children to tackle anaemia and other micro-nutrient deficiencies in women and children. Further, under Mission Poshan 2.0, only fortified rice is being allocated to all the States/UTs. In addition, States/UTs are supplementing the Supplementary Nutrition as per local food habits. States/UTs have been advised to promote use of AYUSH systems for prevention of malnutrition and related diseases. A programme to support development of Poshan Vatikas at Anganwadi Centres to meet dietary diversity gap leveraging traditional knowledge in nutritional practices has also been taken up.

A State-wise statement indicating the quantity of food grains allocated under WBNP and SAG during the current financial year is enclosed at Annexure IV. Further, this Ministry has issued Streamlining Guidelines dated 13.01.2021 on Quality Assurance, Roles and Responsibilities of Duty Holders, Procedure for procurement, integrating AYUSH concepts and Data Management and Monitoring through 'Poshan Tracker' for transparency, efficiency and accountability in delivery of Supplementary Nutrition.
