1080. SHRIMATI SANGEETA AZAD:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government has information on number of workers employed in MSME sector, if so, the details thereof, State-wise and if not, the reasons therefor;
- (b) whether the Government has data with respect to the social security and work security of workers employed in MSMEs and if so, the details thereof; and
- (c) if not, whether the Government proposes to include the same in its next National Sample Survey (NSS) report and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a): As on 05.02.2024, the numbers of persons employed in the MSMEs which are registered on Udyam Registration Portal and Udyam Assist Platform, are 16,86,64,562 (from 01.07.2020 to 05.02.2024). The State/UT wise details are attached in annexure I.
- (b) & (c): The 73rd round National Sample Survey on Unincorporated Non-agricultural Enterprises conducted by Ministry of Statistics & PI in 2015-16 and the ongoing Annual Survey of Unincorporated Sector Enterprises collect information on the contribution to insurance, provident fund and other social security schemes (average for a month) under the block Compensation to workers.

The Government is providing social security to the workers under various Acts, which include The Employees Provident Fund & Miscellaneous Provisions Act, 1952, The Employees State Insurance Act, 1948, The Payment of Gratuity Act, 1972, The Employees Compensation Act, 1923 and The Maternity Benefit Act, 1961.
