## Ayush Hospitals and Dispensaries in Andhra Pradesh

#### 110. SHRI KURUVA GORANTLA MADHAV:

Will the Minister of AYUSH be pleased to state:

- (a) the details regarding the total number of AYUSH hospitals and dispensaries functioning across the country, State/UT-wise including Andhra Pradesh;
- (b) whether the Government proposes to set up any integrated AYUSH Hospital under the National AYUSH Mission (NAM) in Andhra Pradesh;
- (c) if so, the details thereof; and
- (d) the steps taken/proposed to be taken by the Government to link healthcare facilities of AYUSH with the mainstream healthcare set-up?

#### **ANSWER**

# THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

- (a) The total number of Ayush hospitals and dispensaries functioning across the country, State/UT-wise including Andhra Pradesh, are furnished as Annexure-I.
- (b) & (c) Public Health being a state subject, setting up of integrated Ayush hospitals comes under the purview of respective State/UT Governments including Andhra Pradesh. However under NAM there is a provision of providing financial assistance to State/UT Governments for the establishment of 50/30/10 bedded integrated Ayush hospitals. In this regard proposal is required to be submitted by the respective State/UT Governments through State Annual Action Plans (SAAPs) as per the provisions of NAM guidelines. As per the proposals received from the State Government of Andhra Pradesh through SAAP, Ministry has approved two units of integrated Ayush hospitals, one each at Kakinada and Vishakhapatnam.

(d) Government of India has adopted a strategy of Co-location of Ayush facilities at Primary Health Centres (PHCs), Community Health Centres (CHCs) and District Hospitals (DHs), thus enabling the choice to the patients for different systems of medicines under a single window. The engagement of Ayush doctors/ paramedics and their training is supported by the Ministry of Health & Family Welfare under National Health Mission (NHM), while the support for Ayush infrastructure, equipment/ furniture and medicines are provided by the Ministry of Ayush under NAM as shared responsibilities.
