Will the Minister for HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government has conducted Swachh Survekshan, 2023 recently and if so, the details along with the objectives and salient features thereof;**
- (b) whether the Government has released the results of the Swachh Survekshan, 2023 and if so, the details of the ranking of cities along with the cities which have been declared as the cleanest during the last three years including the current year;**
- (c) the criteria for selection of the cities and the details of indicators/parameters taken into consideration during the selection procedure;**
- (d) whether the Government proposes to support those urban local bodies and address their problem of uncleanliness which lags behind in Swachh Survekshan, 2023 and if so, the details thereof and details of efforts made/proposed to be made in this regard along with the outcomes achieved;**
- (e) the details of financial assistance given by the Union Government to States/UTs during the last five years to improve cleanliness in cities; and**
- (f) the other steps taken/being taken to make the Swachh Survekshan successful and to create awareness amongst all sections of the society for cleaner cities?**

ANSWER

(a) : To accelerate the Mission implementation across all urban areas, MoHUA has been conducting an annual cleanliness survey – Swachh Survekshan since the year 2016, which has over the years played a key role in triggering positive competition amongst cities towards achieving the objectives of the Mission. This annual survey ranks cities on various cleanliness parameters, conducted through a significantly rigorous process, has enthused cities and States/UTs to compete positively with each other to be ranked as the cleanest city/ State.

The theme for this edition of Swachh Survekshan (2023) is ‘Waste to Wealth’ and the survey has been conducted in more than 92,000 wards across 4,416 cities. Over 1.75 crore citizens have provided their feedback through various channels along with assessor visits to around 10 lakh households, 20,841 waste processing facilities and 29,640 public and community toilets.

(c): The criteria for selection of the cities and the details of indicators/parameters taken into consideration during the selection procedure is available in the SS 2023 toolkit available on the SBM-Urban website – <https://sbmurban.org>

(d): MoHUA has been providing support to such Urban Local Bodies. Regular capacity building workshops are being conducted in States which includes analysis of the SS 2023 results with focused on the gaps that need to be filled it in the lagging cities. MoHUA also provides technical and financial assistance to address the gaps in performance of lagging cities.

(e): The details of financial assistance given by the Union Government to States/Uts during the last five years are attached as Annexure.

(f): The following steps being taken to make the Swachh Survekshan successful and to create awareness amongst all sections of the society for cleaner cities:

- **The Swachh Survekshan 2023 results dashboard was release and is available in public view on the SBM-Urban website <https://sbmurban.org> . This provides details of city's and state's performance in SS 2023.**
- **A city report card for each city has been provided on the SBM-Urban website <https://sbmurban.org> in public view. This provides a consolidated view of a city's performance on key indicators under SS 2023.**
- **Capacity building workshops are being conducted in States which includes analysis of the SS 2023 results along with understanding of the SS 2024 toolkit for better performance in next year's survey.**
