### Will the MINISTER of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether the Government proposes to implement Rashtriya Bal Swasthya Karyakram in the country and if so, the details thereof along with the achievements made since its inception till date;
- (b) whether the Government has evaluated the scheme through social audit and if so, the details thereof along with the findings of such evaluation;
- (c) the details of the funds allocated and utilized under the scheme during the last three years and the current year along with the number of children covered under the scheme since its inception;
- (d) whether the Government proposes to set up state of art laboratories in the Union Government run hospitals/healthcare centres to detect the genetic disorder/other diseases through pre-natal diagnostic tests; and
- (e) if so, the details thereof along with the funds allocated for this purpose?

#### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (e) Ministry of Health and Family Welfare (MoHFW) implements Rashtriya Bal Swasthaya Karyakram (RBSK) in all States/UTs under National Health Mission (NHM), for children in age group 0-18 years in Anganwadi centres, Government and Government aided schools with the objective of early identification and management for 32 selected health conditions - 4 D's i.e. Defects at Birth, Developmental delays, Diseases and Deficiencies.

As reported by States/UTs, 168.07 crore children have been screened, 11.13 crore children have been identified with selected health conditions and 5.36 crore children have been provided secondary/tertiary care from FY 2013-14 till FY 2023-24 (upto Sept. 2023) under RBSK. State/UT wise details are placed at Annexure-1.

The technical and financial support is provided to the States/UTs under the NHM for infrastructure, essential equipment and required human resources at District Early Intervention

centers (DEICs) including capacity building for comprehensive management of selected health conditions. The State/UT-wise details of the budget allocation and utilization for RBSK is placed at Annexure-2.

The RBSK Program is evaluated under NHM through review of quarterly reports, field visits and periodic meetings with State Nodal Officers, reviews during the process of Annual Programme Implementation Plans (APIP) and Common Review Missions (CRM).

The Department of Biotechnology started the Unique Methods for Management of Inherited Disorders (UMMID) initiative to address the burden of genetic disorders in the country. One of the components of the UMMID initiative is establishing NIDAN Kendras (National Inherited Disorders Administration Kendras) for providing clinical care broadly encompassing the activities of prenatal testing for genetic disorders, newborn screening for relatively common treatable genetic metabolic disorders, and genetic counseling of pregnant mothers carrying fetuses with high risk of genetic disorders.

Under this initiative,11 NIDAN Kendras have been established at Government hospitals spread in eight States of the country. The total sanctioned cost of the UMMID Initiative is Rs. 35 Crores.
