Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the extent to which the children have benefitted from Integrated Child Development Services (ICDS) scheme run by the Government for the overall development of children during the last three years, State-wise and district-wise including Sonipat Parliamentary Constituency in Haryana;
- (b) the number of Non-Governmental Organizations involved in the implementation of the said programme, State-wise; and
- (c) the details of the Centrally Sponsored schemes being implemented for empowerment of women and development of children in the Maharashtra particularly in Amravati district during the last five years and current year scheme-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT
(SHRIMATI SMRITI ZUBIN IRANI)

(a) In the 15th Finance Commission, components of nutritional support for children below the age of 6 years, pregnant women and lactating mother, Adolescent Girls (14 – 18 years); Early Childhood Care and Education [3-6 years]; Anganwadi infrastructure including modern, upgraded Saksham Anganwadi, POSHAN Abhiyaan and Scheme for Adolescent Girls have been reorganized under Mission Saksham Anganwadi and Poshan 2.0 (Mission Poshan 2.0). Mission Poshan 2.0 focuses on Maternal Nutrition, Infant and Young Child Feeding Norms, Treatment of MAM/SAM and Wellness through AYUSH practices to reduce wasting and under-weight prevalence besides stunting and anaemia.

Saksham Anganwadi and Poshan 2.0 is a Centrally Sponsored Scheme and is being implemented in all the 36 States/UTs covering all the districts of the country.

List of State Wise beneficiaries of Mission Poshan 2.0 is at **Annexure I**.

List of district-wise beneficiaries of Mission Poshan 2.0 in state of Haryana including Sonipat District is at **Annexure II**.

(b) No Non-Governmental Organization is involved in the implementation of Mission POSHAN 2.0.

(c) In the 15th Finance Commission, for better implementation and efficient monitoring, all Centrally Sponsored Schemes of the Ministry being implemented in all 36 States/UTs including Maharashtra for the welfare of women and children, have been clubbed into three verticals, viz. (1) Saksham Anganwadi & Poshan 2.0 for improving nutrition indicators in the country (2) Mission Shakti, for safety, protection and empowerment of women; and (3) Mission Vatsalya, for protection and welfare of children. The details of the schemes are as under:

(i) Saksham Anganwadi & Poshan 2.0 (Mission Poshan 2.0): In the 15th Finance Commission, components of nutritional support for children below the age of 6 years, pregnant women and lactating mother, Adolescent Girls (14 – 18 years); Early Childhood Care and Education [3-6 years]; Anganwadi infrastructure including modern, upgraded Saksham Anganwadi, POSHAN Abhiyaan and Scheme for Adolescent Girls have been reorganized under Mission Saksham Anganwadi and Poshan 2.0 (Mission Poshan 2.0). Mission Poshan 2.0 focuses on Maternal Nutrition, Infant and Young Child Feeding Norms, Treatment of MAM/SAM and Wellness through AYUSH practices to reduce wasting and under-weight prevalence besides stunting and anaemia.

(ii) Mission Shakti: Mission Shakti comprises of two sub-schemes '**Sambal**' and '**Samarthya**' for safety and security of women and empowerment of women respectively. The existing schemes of One Stop Centres (OSC), Women Helplines (181-WHL) and Beti Bachao Beti Padhao (BBBP) have been made part of Sambal sub- scheme; while the existing schemes of Pradhan Mantri Matru Vandana Yojana (PMMVY), Ujjwala, Swadhar Greh (renamed as Shakti Sadan) and Working Women Hostel (renamed as Sakhi Niwas), National Hub for Empowerment of Women (NHEW) and National Creche Scheme (renamed as Palna) have been subsumed in 'Samarthya'.

(iii) Mission Vatsalya: Mission Vatsalya has subsumed Integrated Child Protection Scheme (ICPS) for better outreach and protection for children in need and care in a mission mode with the objective to: (i) Support and sustain Children in difficult circumstances. (ii) Develop context-based solutions for holistic development of children from varied backgrounds. (iii) Provide scope for green field projects for encouraging innovative solutions. (iv) Cement convergent action by gap funding, if required.
