Will the Minister of Women and Child Development be pleased to state:

- (a) the number of One Stop Centres (OSCs) approved across districts in the country as on date, State-wise including Odisha;
- (b) the budgetary norms for construction of OSCs;
- (c) the number of OSCs operational as on date, State-wise including Odisha; and
- (d) the number of OSCs proposed to be set up during the period of XV Finance Commission in country including Karnataka, district-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) to (d): The Government has been implementing the scheme of One Stop Centre (OSC) since 1st April, 2015 to provide a range of integrated services under one roof to women affected by violence and in distress. These services include Police facilitation, medical aid, providing legal aid and legal counselling, psycho-social counselling and temporary shelter. So far, a total of 816 One Stop Centres have been approved in all 36 States/UTs, out of which 757 OSCs are operational. The budgetary norms for construction of One Stop Centre is based on CPWD 2020 rates to the tune of Rs.60.00lakh (Tentative) for Delhi and National Capital Region. The rates for other regions/locations is as per the Schedule of Rates (SOR) of the Concerned States/UTs. A variable cost @5% of the construction cost to meet any variation in the construction cost is also provided. The State/UT wise approved and functional OSCs are annexed at **Annexure**.

A third party evaluation of the schemes of the Ministry, including One Stop Centre (OSC) Scheme, was conducted during the Financial Year 2020-21 through NITI Aayog. The study found the relevance, effectiveness and sustainability of the scheme as satisfactory. Based on the recommendations of the Third Party Evaluation, the OSC scheme has been included as a component of sub-scheme 'Sambal' under Mission Shakti for implementation during period of 15th Finance Commission Cycle upto 2025-26. Based on the encouraging results of this initiative and benefits to women, 300 more OSCs are envisaged to be set up during the period of 15th Finance Commission in the districts having higher rate of crime against women or having bigger geographical area, preferably in aspirational districts.
