- (a) the objective of launching the SWAMIH Scheme;
- (b) the number of stalled projects funded under SWAMIH Scheme since its inception, State/year-wise;
- (c) the number of projects completed with help of SWAMIH;
- (d) the number of projects being completed under SWAMIH and the status of their completion; and
- (e) the total amount of projects funded by SWAMIH under completion and completed, State-wise?

ANSWER

MINISTER OF STATE (FINANCE) (SHRI PANKAJ CHAUDHARY)

- (a): A Special Window for Affordable & Mid-Income Housing (SWAMIH) scheme was approved by the Cabinet on 06.11.2019. The objective of the scheme was to ensure delivery of homes to buyers by providing priority debt financing for the completion of stressed, brownfield, RERA registered residential projects that are in the affordable housing / mid-income category and require last mile funding across India. The broad criteria of financing under the scheme was that at least 90% of the available Floor Space Index (FSI) / Floor Area Ratio (FAR) is being developed as Affordable Housing units or Mid-Income Housing units; the project is net worth positive; has incurred at least 30% of the project costs and is RERA registered.
- (b): A statement indicating State-wise details of projects funded under SWAMIH scheme since inception, as on December 31, 2023 is at **Annexure-I.**
- (c) to (e): A Statement indicating State-wise details of the number of projects completed and under various stages of completion, along-with aggregate deal size is at **Annexure-II**.
