# GOVERNMENT OF INDIA MINISTRY OF LABOUR AND EMPLOYMENT LOK SABHA UNSTARRED QUESTION NO. 363 TO BE ANSWERED ON 05.02.2024

#### PERFORMANCE OF STATE RUN ESIS

#### 363. SHRI E.T. MOHAMMED BASHEER:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a)whether the Government is aware that there are large number of under performing State run ESI's in the country;
- (b)if so, the details thereof;
- (c)whether the Government have made any survey in this regard; and
- (d)the steps taken by the Government for activising such ESI hospitals?

  ANSWER

### MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SHRI RAMESWAR TELI)

(a) to (d): As reported on various occasions, some of the State run ESI hospitals have lack of in-house medical care services. List of underutilised ESIS hospitals having bed occupancy less than 60 % are place at Annexure.

Health is a state subject and ESIS hospitals are under the direct administrative control of the respective State Govts. However, ESIC has taken up the issue of improvement of ESIS hospitals with the state authorities at various forums. In the conference for Labour Secretaries held in June 2023 and Nov 2023, ESIC and the state representatives discussed about the importance of provision of medical services, posting of medical and para-medical staff as per sanctioned strength, procurement of required equipment and para-medical staff as per the sanctioned strength to improve the patient care in all state ESIS hospitals.

Further, to improve the functioning of ESIS hospitals, ESIC has sent request to all State Govt. to hand over their ESIS hospitals under the complete control of ESIC for improving the medical services. In addition to this, ESIC has also requested all the State Govts. in respect of newly approved ESI hospitals to give consent for running the hospitals by ESIC directly. Opening of these newly approved hospitals will address the shortage of ESI hospitals.

ESI Corporation has taken various initiatives to improve the quality of services in State run ESI hospitals, as under:

- a. ESIS hospitals of all the states are fully financially supported by ESIC through On-Account Payment (OAP) of prescribed ceiling of Rs 3000/- per IP per annum.
- b. ESIC provides Rs.200/- per IP per annum over and above the ceiling to the State Govt., where the bed occupancy in all the State run ESIS hospitals is more than 70% during the concluded financial year.
- c. Formation of ESI State Society at state level so that they have adequate administrative and financial freedom to take decisions for improvement of medical services.
- d. For regular monitoring of the performance of ESIS hospitals, ESIC has given instructions to the Zonal Medical Commissioners to carry out periodic inspections and ensure the improvement of medical services in ESIS hospitals.
