WOMEN ENTREPRENEURSHIP

371. SHRI C.N. ANNADURAI: SHRIMATI MANJULATA MANDAL:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

(a) whether the Government has launched any programmes to promote women entrepreneurship in Tamil Nadu;

(b) if so, the details thereof, district-wise;

(c) the details of the capacity building programmes started by various Self Help Groups in different districts of Tamil Nadu; and

(d) the details of the assistance provided to the Startups established and run by women in various districts of Tamil Nadu?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

(a) to (d) Under the Government of India's Skill India Mission (SIM), the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, re-skill and up-skill training through an extensive network of skill development centres/colleges/institutes etc. under various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society across the country. The SIM aims at enabling youth of India to get future ready & industry ready skills.

The Government has taken various initiatives to promote women entrepreneurship across the Country including the State of Tamil Nadu. The details of the various initiatives taken by Ministries/Departments of the Government to promote women entrepreneurship is as under:

1. **Ministry of Rural Development** is implementing Rural Self Employment Training Institutes (RSETIs) scheme in the field of skill development for rural poor youth for their gainful employment with a view to eradicate poverty in the country under the umbrella scheme of Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM). The RSETIs extend free cost training to the rural unemployed youth in skill and entrepreneurship development, to enable them to become self-employed by establishing their own small and micro enterprises. Out of the 591 RSETIs functioning across the country, 35 RSETIs are functioning in 35 districts of Tamil Nadu State. The district wise details of number of women candidates trained and settled during FY 2022-23 and 2023-24 up to 31.12.2023 in Tamil Nadu is at **Annexure-I**.

Further, Start-up Village Entrepreneurship Programme (SVEP), a sub-scheme under the Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM) programme supports the Self-Help Group (SHG) and their family members to set-up small enterprises in the non-farm sector. SVEP develops an eco-system for enterprise development in rural areas, with SHG households, which includes Community Enterprise Fund (CEF) (a dedicated fund for providing loans to entrepreneurs) and Cadre of Community Resource Persons-Enterprise Promotion (CRP-EP) for providing Business Support Services. Under SVEP, the project cost for one block is Rs 6.50 Crore (inclusive of Government of India and State Share) out of which Government of India (GoI) share is 90% for North Eastern Region (NER) and Hilly states while it is 60% for the remaining States. Till 31st December, 2023, a total of 4409 enterprises are supported in the State of Tamil Nadu. The Blocks/district-wise details of the enterprises supported under SVEP in the State of Tamil Nadu are as under:

2. **Department of Financial Services** - Pradhan Mantri Mudra Yojana (PMMY) was launched on 08.04.2015 to extend collateral free credit up to Rs.10 lakh by Member Lending Institutions (MLIs), i.e., Scheduled Commercial Banks (SCBs), Non-Banking Financial Companies (NBFCs) and Micro Finance Institutions (MFIs). Any individual, who is otherwise eligible to take a loan and has a business plan for small business enterprise can avail loan under the Scheme for income generating activities in the manufacturing, trading, service sectors including activities allied to agriculture across three loan categories, viz. Shishu (loans up to Rs. 50,000/-), Kishor (loans above Rs. 50,000/- and up to Rs. 5 lakh) and Tarun (loans above Rs. 5 lakh and up to Rs.10 lakh). As on 26.01.2024, a total of 46.15 crore loans have been extended under PMMY, since inception of the Scheme. Out of this more than 31.20 crore loans (68%) have been sanctioned to Women entrepreneurs. The district-wise details for loans sanctioned under PMMY for the State of Tamil Nadu is at **Annexure-II**.

Stand-Up India (SUI) Scheme launched on 05.04.2016 has been extended up to the year 2025. The objective of the Scheme is to facilitate loans from Scheduled Commercial Banks (SCBs) of value between Rs. 10 lakh and Rs. 1 crore to at least one Scheduled Caste (SC) or Scheduled Tribe (ST) borrower and one Woman borrower per bank branch for setting up greenfield enterprise in manufacturing, services or trading sector including activities allied to agriculture. Further, an online portal has been developed by SIDBI for the Stand Up India Scheme which provides support through more than 8000 active Hand Holding Agencies to prospective entrepreneurs in their endeavour to set up business enterprises, starting from training to filling up Ioan applications. The Stand Up India scheme has facilitated over 2.16 lakh Ioans to SC/ST and Women entrepreneurs across the country. Out of this more than 1.82 lakh Ioans (84%) have been sanctioned to Women entrepreneurs as on 25.01.2024 since inception of the Scheme. The district-wise details for Ioans sanctioned under SUPI for the State of Tamil Nadu is at **Annexure-III**.

3. **Department for Promotion of Industry and Internal Trade (DPIIT)** - In order to build a strong ecosystem for nurturing innovation and startups across the country for all the genders, the Government launched the Startup India initiative on 16th January 2016. As per eligibility conditions prescribed under Notification No. 127 (E) dated 19th February 2019, entities are recognized as 'startups' under Startup India initiative by the Department for Promotion of Industry and Internal Trade (DPIIT). As on 31st December 2023, a total of 1,17,254 entities have been recognised as startups, of which, 55,816 startups have at least one woman Director. In the State of Tamil Nadu, there are a total of 7,559 DPIIT recognised startups, out of which 3,688 startups have at least one-woman Director.

4. **Ministry of Electronics and Information Technology (MEITY)** has initiated various startup centric programmes/scheme to encourage the innovation led startup ecosystem to develop indigenous products in ICT domain pan India basis including startups led by Women Entrepreneurs in the State of Tamil Nadu. These initiatives are for the promotion of startups and entrepreneurs irrespective of gender and applicable for women entrepreneurs also. The major initiatives are as under:

(i) TIDE 2.0 Scheme: Technology Incubation and Development of Entrepreneurs (TIDE 2.0) Scheme was initiated in the year 2019 to promote tech entrepreneurship through financial and technical support to incubators engaged in supporting ICT startups using emerging technologies such as IoT, AI, Block-chain, Robotics etc. The scheme aims to provide comprehensive support to tech-startups in seven thematic areas of National concern by leveraging emerging technologies. The Scheme is being implemented through 51 incubators to provide incubation support to approximately 2000 tech startups over a period of five years. Under TIDE 2.0 Scheme, the following 6 incubation centres are functioning as TIDE 2.0 centres in the State of Tamil Nadu:

(ii) Centre of Excellence on FinTech (FinBlue): FinTech Centre of Excellence (CoE) setup at Software Technology Parks of India (STPI) Chennai for supporting the Startups in FinTech domain with a target beneficiary of 58 startups over a period of 5 years. The FinTech CoE is supported by MeitY, Government of India in partnership with Government of Tamil Nadu and STPI.

(iii) SAMRIDH Scheme: MeitY has initiated 'Start-up Accelerator Programme of MeitY for Product Innovation, Development and Growth (SAMRIDH)'Scheme with an aim to support existing and upcoming Accelerators to further select and accelerate potential software product based start-ups to scale. A total of 300 startups are to be supported under the SAMRIDH Scheme for a duration of 3 years. Under the SAMRIDH Scheme, the following 2 accelerators are functioning in the State of Tamil Nadu:

5. Ministry of Women & Child Development - The Government of India implements 'Mission Shakti' - an integrated women empowerment programme as umbrella scheme for safety, security and empowerment of women. The Umbrella Scheme of Mission Shakti has two sub-schemes namely "Sambal" and "Samarthya". 'Samarthya' sub- scheme, has a component i.e. Hub for Empowerment of Women (HEW) at National, State and District levels for Empowerment of Women. HEW aims to facilitate inter-sectoral convergence of schemes and programs meant for women at the Central, State/ UT and district levels with the mandate to create an environment in which women realize their full potential. The support under the HEW is for guiding, linking and hand holding women to various institutional and schematic set ups for their empowerment and development including facilitating access to healthcare, quality education, career and vocational counseling/ training, financial inclusion, entrepreneurship, backward and forward linkages, health and safety for workers, social security and digital literacy at districts/ Blocks/ Gram Panchayats level across the country.

6. **Ministry of Micro Small and Medium Enterprises (MSME)**, through Khadi and Village Industries Commission (KVIC), is implementing Prime Minister's Employment Generation Programme (PMEGP) for assisting entrepreneurs in setting up of new micro units in the non-farm sector. It aims to provide employment opportunities to traditional artisans/ rural and urban unemployed youth at their doorstep. Under PMEGP, General Category beneficiaries can avail of Margin Money (MM) subsidy of 25% of the project cost in rural areas and 15% in urban areas. For beneficiaries belonging to Special Categories such as Scheduled Castes, Scheduled Tribes, OBCs, Minorities, Women, Ex-servicemen, Differently-abled, Transgenders, beneficiaries belonging to

Northeastern Region, Hill and Border areas, and Aspirational Districts, the Margin Money subsidy is 35% in rural areas and 25% in urban areas. The maximum cost of project is Rs. 50 lakhs in the manufacturing sector and Rs. 20 lakhs in the service sector. Also, own contribution of beneficiaries under Special Category including women is 05% and 10% for General Category beneficiaries.Since 2018-19, existing PMEGP/REGP/MUDRA enterprises are also supported based on past good performances with 2nd loan for upgradation and expansion. Under 2nd Loan, maximum project cost admissible for Margin Money (MM) subsidy under Manufacturing sector is Rs. 1.00 crore and for Service sector is Rs. 25 Lakhs. Eligible subsidy on 2nd loan for all categories is 15% of project cost (20% for NER & Hill States). The district-wise performance of PMEGP units owned by women in the state of Tamil Nadu during last 3 Years and current year is at **Annexure-IV**.

7. **Ministry of Skill Development and Entrepreneurship (MSDE)** through National Institute for Entrepreneurship and Small Business Development (NIESBUD) has been working for the empowerment, upliftment and development of women entrepreneurs across the country including the State of Tamil Nadu. NIESBUD has conducted an Entrepreneurship Awareness Programme (EAP) for the Tribal Community under the PM-JANMAN Project. Under the project, 95 Female candidates have been trained in Nilgiris District of Tamil Nadu.
