Will the Minister of FINANCE

Be pleased to state:

- (a) the per capita income in the country, State-wise;
- (b) the percentage of increase in per capita income during the last five years, State-wise;
- (c) whether per capita income has not increased in proportion to the growth of GDP; and
- (d) if so, the details thereof and the reasons therefor?

ANSWER

MINISTER OF STATE FOR FINANCE (SHRI PANKAJ CHAUDHARY)

- (a): The per capita income in the country, state-wise, measured in terms of per capita net state domestic product (NSDP) by the Ministry of Statistics and Programme Implementation (MoSPI), is given in **Annexure I** for 2022-23 in current prices.
- **(b):** The percentage increase in per capita NSDP at current prices during the last five years is given in **Annexure-II.**
- (c)-(d): The per capita income in the country at the national level, also estimated as per capita GDP by MoSPI, is obtained after netting out population growth from GDP growth. Since population growth is positive in India, the growth in per capita GDP is not in the same proportion as GDP growth.
