## **PM-JANMAN**

405. DR. UMESH G. JADHAV:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the objectives and crucial interventions of the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN);and
- (b) the current status of the PM-JANMAN scheme and the number of tribal communities have experienced benefits from this scheme particularly in Karnataka, district-wise?

## **ANSWER**

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI BISHWESWAR TUDU)

(a) & (b): Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PMJANMAN) aims to saturate PVTG households and habitations with basic facilities such as safe housing, clean drinking water and sanitation, improved access to education, health and nutrition, road and telecom connectivity, electrification of unelectrified households and sustainable livelihood opportunities in a mission mode manner in 3 years.

PM-JANMAN focuses on 11 critical interventions to cover all the eligible PVTG beneficiaries / PVTG villages & habitations based on the existing gaps being captured through mobile app developed for the purpose through BISAG-N. PM-JANMAN is in implementation stage with benefits aimed at 75 tribal communities identified as PVTGs including two PVTGs viz Jenu Kuruba and Koraga in the state of Karnataka. The 11 interventions are being implemented by the 9 Ministries. Each Ministry is responsible for implementation of scheme as can be seen from the activities / projects sanctioned for the State of Karnataka, District-wise, under PM-JANMAN are as per details below:
