**FINANCIAL ASSISTANCE TO FARMERS FOR OPERATING DAIRY INDUSTRY**

623. SHRI KAUSHALENDRA KUMAR:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

मत्स्यपालन, पशुपालन और डेयरी मंत्री

be pleased to state:

- (a) the details of assistance being provided by the Government to farmers for operating dairy Industry and the development thereof;
- (b) the total number of farmers to whom assistance amount has been released during each of the last five years and the current year, State-wise;
- (c) whether interest is also being charged from the farmers over the loans provided under the said scheme; and
- (d) if so, the details thereof including the amount of interest being charged from the farmers?

**ANSWER**

**THE MINISTER FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING**

**(SHRI PARSHOTTAM RUPALA)**

(a) to (d) Department of Animal Husbandry and Dairying is providing assistance to dairy farmers under the following components/ schemes:

(i) Rashtriya Gokul Mission is providing breeding support to the more than 8 crore farmers engaged in dairying.

(ii) One of the components of the scheme Rashtriya Gokul Mission is to promote establishment of breed multiplication farm on hub and spoke model. Under the scheme 50% capital subsidy is available for eligible entrepreneurs (individual/ SHGs/FCO/FPO/JLGs and section 8 companies) and so far 111 breed multiplication farms has been sanctioned. Entrepreneurs assisted under establishment of breed multiplication farm are also eligible for interest subvention under Animal Husbandry Infrastructure Development Fund.

(iii) Animal Husbandry Infrastructure Development Fund (AHIDF) – under the scheme 3% interest subvention is made available to the beneficiaries availing credit under the scheme.

(iv) Government has extended Kisan Credit Card facility to Animal Husbandry farmers including farmers for their working capital requirements wherein farmers either individual or joint borrower, Joint Liability Groups or Self Help Groups including tenant farmers having owned/rented/leased sheds are eligible for getting benefits under the scheme.

Dairy farmers supported under Nationwide artificial insemination programme of Rashtriya Gokul Mission during the last 5 years and current year State wise is at Annexure-I.
