ACHIEVEMENTS UNDER PMKSY

677. MS. S. JOTHIMANI: ADV. DEAN KURIAKOSE:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the number of proposals that State Governments have sent and the number of proposals sanctioned by the Union Government under PMKSY, State-wise especially for the State of Tamil Nadu;
- (b) the budgetary allocation for Production Linked Incentive and expenditure for the last three years; and
- (c) whether the Government has achieved the set targets of setting up food processing industries under PMKSY, if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (KM SHOBHA KARANDLAJE)

- (a) : The Ministry of Food Processing Industries (MoFPI) has been implementing a Central Sector umbrella scheme Pradhan Mantri Kisan Sampada Yojana (PMKSY) since 2017-18. 31 proposals (including 11 projects for the State of Tamil Nadu) have been approved till 25.01.2024 against 87 proposals (including 28 proposals from the State of Tamil Nadu) received from the State Governments and their organisations. State/UT –wise details of the same are at **Annexure**.
- (b) : The budgetary allocation and expenditure incurred under Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) for the last three years are as under:

(c) : The PMKSY is one of the important interventions being implemented by the Government in Food Processing Sector since 2017-18 and it has made substantial contribution in strengthening food processing infrastructure of the country. Rs. 6000 crore was allocated for the 14th Finance Commission Cycle (FCC) period. During 15th FCC period, Rs. 4600 crore has been allocated which includes Rs. 2630 crore for committed liabilities. As on 25.01.2024, 1115 projects (579 completed and 536 ongoing) have been approved with total project cost of Rs. 22,918.64 crore, which includes grants-in-aid of Rs. 5979.59 crore leading to creation of processing/preservation capacity of 293.93 lakh MT, generation of 5.97 lakh employment and benefitting 38.03 lakh farmers.
