**(a): As on 02.02.2024, the total number of beneficiaries under Pradhan Mantri Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Scheme in the State of Karnataka is 3,47,662.**

**(b): As on 02.02.2024, the total number of beneficiaries is 4,192 under PM SVANidhi Scheme in Mandya district of State of Karnataka.**

**(c) & (d): As on 02.02.2024, total 1,56,422 number of loans have been repaid in the State of Karnataka. The term wise details of total number of loans repaid in State of Karnataka under the PM SVANidhi Scheme are at Annexure-I.**

**(e): As on 02.02.2024, total 5,658 number of loans have been disbursed by the Scheduled Commercial Banks in Mandya district. The Bank wise details of number of beneficiaries in Mandya District are at Annexure-II.**
