STATEMENT IN REPLY TO PART (a) to (d) OF LOK SABHA STARRED QUESTION NO.*26 TO BE ANSWERED ON 19.11.2019 REGARDING HOUSES UNDER PRADHAN MANTRI AWAAS YOJANA – GRAMIN

(a) to (d): To achieve the objective of "Housing for All" by 2022, Ministry of Rural Development implements Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) (restructured from the erstwhile Indira Awaas Yojana (IAY)), with effect from 01.04.2016.

Under PMAY-G, 1,98,608 houses have been constructed against the target of 5,27,552, as on 15.11.2019. A total of 1,98,136 houses have been completed in Phase I (2016-17 to 2018-19) against the target of 3,27,552 houses. In the year 2019-20 of Phase II (2019-20-2021-22), 472 houses have been completed against the target of 2,00,000 houses.

A Statement indicating district-wise details including Tirunelveli District, of number of beneficiaries, funds allocated, funds utilized, houses allocated and houses constructed in the State of Tamil Nadu under PMAY-G is given at **Annexure-I**.
