MODERNISATION OF EMPLOYMENT EXCHANGES

115. SHRI KRUPAL BALAJI TUMANE:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the total number of employment exchanges functioning in the States/UTs including Maharashtra at present and the details of current status of upgradation and modernization of employment exchanges, State/UT-wise;
- (b) the details of funds allocated, released and used during each of the last three years and the current year, State/UT-wise; and
- (c) whether the progress of modernization in this regard is going on in all the States including Maharashtra as per target, if so, the details thereof and if not, the reasons therefor and the corrective steps taken by the Government in this regard?

ANSWER

MINISTER OF STATE (IC) FOR LABOUR AND EMPLOYMENT (SHRI SANTOSH KUMAR GANGWAR)

(a): As per the information received from the States/UTs, the number of employment exchanges functioning in the country are 997 including Maharashtra. The State-wise detail is at Annexure -I.

(b) & (c): The Ministry is implementing the National Career Service (NCS) Project for transformation of the National Employment Service to provide a variety of employment related services like job matching, career counselling, vocational guidance, information on skill development courses, etc. These services are available online on the National Career Service Portal (<u>www.ncs.gov.in</u>).

The NCS Project also envisages setting up of Model Career Centres (MCCs) in collaboration with States and other institutions of repute to deliver employment services. Ministry has approved 164 Employment Exchanges for establishment of Model Career Centres. The Central Government provides financial assistance to the States for establishment of MCCs based on the proposals and scheme guidelines. The State-wise, including Maharashtra, details of funds approved, released and utilized are at Annexure-II. These Model Career Centres can be replicated by the States from their own resources.

In addition, the NCS project has a component of interlinking of employment exchanges with NCS and provides assistance to States for upgradation of infrastructures in employment exchanges. The Government provides financial assistance based on the proposals received from states and scheme guidelines. Funds have been released to 24 States/UTs as per details at Annexure-III.
