CHRONOLOGICAL ORDER IN SKILL DEVELOPMENT

1259. SHRI RAJESHBHAI CHUDASAMA:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- a) the names of the States in the country, in chronological order in terms of growth in Skill Development and entrepreneurship;
- (b) the number of Skill Development Centres (SDCs) established so far during the last three years and the number of unemployed persons provided employment, State-wise;
- (c) the amount provided by the Government to the States in the said period under the said scheme; and
- (d) whether the Government proposes to increase this amount and if so, the details thereof and if not, the reasons therefor?

(a) and (b) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship through National Skill Development Corporation (NSDC) is implementing a flagship scheme Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 2016-20. This scheme has two components known as Centrally Sponsored Centrally Managed (CSCM) being implemented by NSDC and Centrally Sponsored State Managed (CSSM) being implemented by State Skill Development Missions of the States/ UTs. Under the PMKVY 2016-20 scheme, as on 11.11.2019, 69.03 lakh (appx.) candidates have been trained under STT (38.01 lakh) and RPL (31.02 lakh) across the country in various sector. The State wise details of the candidates trained in chronological order (highest to order) under PMKVY 2016-20 is given at **column (a) of table at Annexure.**

Under PMKVY 2016-20, for imparting the skill training, the accreditation and affiliation of training centres (TCs) is done under single window IT application known as SMART. As on 11.11.2019, 13,911 TCs have been empanelled under PMKVY 2016-20. The State/UT-wise details of Training Centers under PMKVY 2016-20 are given at **column (b) of table at Annexure.**

(c) and (d) CSCM component of PMKVY 2016-20 is being implemented pan India by NSDC, thus, no State/UTs-wise fund is sanctioned under this component. However, under CSSM component of PMKVY 2016-20, 25% of the funds and corresponding physical targets of PMKVY 2016-20 have been allocated to the States/UTs for the implementation of scheme through State Skill Development Missions. Ministry has received proposals from 36 States/UTs and after evaluation of proposals, Ministry has given in-principle approval of a total target of 20.18 lakh candidates and corresponding financial allocation of Rs. 3,050 Cr. for FY 2016-20. However, due to slow performance of States/UTs and keeping in the mind that the scheme is going to end by March'2020, the financial allocation was rationalised to Rs. 2,419 crore (approx.) with the corresponding physical target of 12.45 lakh. As on 11.11.2019, Rs. 808.96 Cr. (approx) has been disbursed to 36 States/UTs.
