#### **SETTING UP OF NEW COMPANIES**

#### 1524. SHRI JANARDAN MISHRA: SHRI FEROZE VARUN GANDHI:

Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state: वाणिज्य एवं उदयोग मंत्री

- (a) the details of the number of new companies opened in India in the year 2018-19;
- (b) the details of the difference in the total number of new companies when compared to the previous financial year;
- (c) whether the Government has formulated any scheme to set up new industries in such places having abundant resources but no industries;
- (d) if so, the State-wise details thereof; and
- (e) if not, the steps being taken/to be taken by the Government in this regard?

#### **ANSWER**

### वाणिज्य एवं उद्योग मंत्री (श्री पीयूष गोयल) THE MINISTER OF COMMERCE & INDUSTRY (SHRI PIYUSH GOYAL)

- (a) & (b): Information received from Ministry of Corporate Affairs in respect of State/UT wise newly registered companies indicate that during 2017-18 & 2018-19. 1,23,938 companies were registered in 2018-19 as against 1,08,075 companies registered in 2017-18. State wise breakup is at Annexure I.
- (c) to (e): The primary responsibility of industrial development rests with the State Governments. Central Government encourages setting up of industries through various policy measures implemented by different Ministries and Departments. Government has taken several steps to develop the industrial sector which, inter-alia, includes providing quality infrastructure, reducing logistics cost, skill development, Ease of Doing Business and adoption of technology, etc. Further, several new programmes/ initiatives have been undertaken to push the industrial sector of the economy such as Make in India, Skill India, Start-Up India and Stand-Up India, Modified Infrastructure Upgradation Industrial Scheme (MIIUS), Development Scheme for Himachal Pradesh (HP) & Uttarakhand, 2017;

Industrial Development Scheme for Jammu and Kashmir, 2017; North East Industrial Development Scheme (NEIDS), 2017; and the Scheme of Budgetary Support under Goods and Services Tax (GST) Regime to the units located in State of Jammu & Kashmir, Uttarakhand, Himachal Pradesh and North Eastern States including Sikkim. Centralised statistics of the industries set up is not maintained in the Department.
