SETTING UP OF SMALL SCALE INDUSTRIES

1619. SHRI SANJAY JADHAV:
SHRI PARBHUBHAI NAGARBHAI VASAVA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government has released funds for setting up small scale industries under its ongoing scheme during the last three years and if so, the total funds released by the Government, State/year-wise;
- (b) if not, the reasons therefor;
- (c) the total number of small scale industries set up in various States during the last three years;
- (d) the details of the different units of micro, small and medium enterprises proposed to be set up in the State of Gujarat including present status thereof;
- (e) whether the Government has allotted land for setting up of all these units and if so, the details thereof, State-wise; and
- (f) whether any funds have been allocated so far by the Government for these units and if so, the details thereof and the target set for setting up of these units?

ANSWER

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES
(SHRI NITIN GADKARI)

(a) & (b): Yes, Sir. Ministry of Micro, Small and Medium Enterprises (MSME) is implementing Prime Minister's Employment Generation Programme (PMEGP) since 2008. Khadi and Village Industries Commission is the Nodal implementing agency at national level. The scheme is being implemented through all Public Sector Banks, selected private sector Banks and co-operative Banks. Under this scheme, banks provide loan and the margin money subsidy is provided by Ministry of MSME through KVIC. The maximum cost of the project eligible for financing under PMEGP is Rs.25.00 lakh in Manufacturing Sector and Rs.10.00 lakh in Service Sector.

The details of fund disbursed as margin money subsidy to set up micro units under PMEGP during the last three years State-wise is placed at **Annexure-I**.

(c): The total number of micro units setup in various States during last three years under PMEGP is placed at **Annexure – II**.

(d): A target to set up 3367 new micro enterprises under PMEGP scheme has been fixed during the FY 2019-20. Against this target, as on 31.10.2019, 2379 micro units have been established.

(e): No Sir.

(f): As mentioned in part 'd' against the target of setting up of 3367 new micro enterprises under PMEGP scheme an allocation of Rs. 101.01 crore towards margin money subsidy has been fixed during the FY 2019-20.
