Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the status of various projects under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) Scheme in Hazaribagh, Jharkhand;
- (b) the details of sanitation measures taken under AMRUT Scheme along with construction of individual household toilets, community and public toilets in Jharkhand, district-wise; and
- (c) whether new water treatment plants were constructed to promote reusing and recycling of water and if so, the details thereof?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF HOUSING and URBAN AFFAIRS (SHRI HARDEEP SINGH PURI)

- (a). The status of projects under AMRUT in Hazaribagh, Jharkhand is at ANNEXURE-I.
- (b). Under AMRUT, 9 projects worth Rs.251.50 crore have been taken up by the State of Jharkhand in sewerage and septagemanangement sector. Contract for all these 9 projects have been awarded and work is under progress. The details of construction of individual household toilets, community and public toilets in Jharkhand under Swachh Bharat Mission (Urban) is at ANNEXURE-II.
- (c). Under AMRUT, 6 water treatment plants having total capacity of 171 MLD are under construction in Jharkhand, the details of which is at ANNEXURE-III.
