- (f) if so, the details thereof?

(a) & (b): A statement of year-wise externally aided component of budget routed through Controller of Aid Accounts & Audit (CAAA) Division since 2000 is attached.

(c) to (f): External assistance for public health programmes provide focused support in key areas with enhancement of technical expertise and capacities as well as a structured monitoring and review mechanism complementing efforts of the Government of India.

The projects with external funding are generally completed timely. After successful completion, further continuation is supported from funds of Government of India, if warranted.
