## **Revival of Loss Making PSUs**

## 2509: SHRI AJAY NISHAD:

Will the Minister of HEAVY INDUSTRI ES AND PUBLIC ENTERPRISES be pleased to state:

- (a) the details of the Public Sector Undertakings (PSUs) under the Ministries of Agriculture, Petroleum and Natural Gas, Power, Steel, Coal, Mines and Chemicals and Fertilizers, State/UT-wise:
- (b) the details of the PSUs which are earning profits/running in losses along with the reasons for the losses, PSU-wise:
- (c) whether the Government has taken any measures to bail out the undertakings incurring losses; and
- (d) if so, the details thereof?

#### **ANSWER**

# THE MINISTER OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI PRAKASH JAVADEKAR)

(a) & (b): As per Public Enterprises Survey (2017-18) laid in the Parliament on 27.12.2018, there were 155 Central Public Sector Enterprises (CPSEs) under the administrative control of Ministries of Agriculture, Petroleum and Natural Gas, Power, Steel, Coal, Mines, Chemicals and Fertilizers as on 31.3.2018. Out of the 155 CPSEs, 97 are operating CPSEs. The list of these 97 CPSEs State/Union Territories wise along with the details of profit earned /loss incurred during 2017-18 is given at Annex1.

The reasons for losses vary from CPSE to CPSE, however, some common problems in CPSEs for losses which include resource crunch, low productivity, unsustainable business operations, old and obsolete plant & machinery, outdated technology, low capacity

utilization, poor debt-equity structure, weak marketing strategies, stiff competition, lack of business plans, heavy interest burden, high input cost etc.

(c) & (d): DPE has issued Guidelines dated 29.10.2015 for "Streamlining the mechanism for revival and restructuring of sick / incipient sick and weak Central Public Sector Enterprises: General principles and mechanism of restructuring". As per these guidelines, the administrative Ministries / Departments concerned are responsible for monitoring the performance of CPSEs functioning under them and taking timely measures for revival/restructuring of sick/loss making CPSEs on a case to case basis as per the principles outlined in DPE guidelines dated 29.10.2015.
