- a) whether the Government is providing financial assistance to various States for setting up of dairies in the country;
- b) if so, the details thereof including the salient features of the schemes for the purpose along with the amount of assistance provided by Government to various States during the last three years and the current year, State-wise;
- c) whether the Government has any scheme for training of milk producers in the use of new techniques for developing the dairy sector with upgraded technology; and
- d) if so, the details thereof?

**THE MINISTER OF STATE FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(a) & (b) The Department of Animal Husbandry And Dairying, Government of India is providing financial assistance for setting up of dairies under following dairy development schemes:

1. National Programme for Dairy Development (NPDD)

NPDD focuses on creating/ strengthening of infrastructure for production of quality milk, procurement, processing and marketing of milk & milk products. The scheme provides grant-in-aid to the various States of the country for dairy development activities including setting up of dairy plant. The State-wise financial assistance provided by this Department during last three years and current financial year (upto 27.11.2019) under NPDD is at **Annexure – I**.

2. Dairy Entrepreneurship Development Scheme (DEDS)

The scheme provides back-ended capital subsidy at the rate of 25% for General category and 33.33% for SC/ST category for various dairying activities including setting up of small dairy units of 2 to 10 cows/ buffalos through National Bank for Agriculture and Rural Development (NABARD). The major components of the scheme inter-alia includes setting up of small dairy unit, heifer unit, purchase of milking machines, bulk milk cooling units dairy processing equipment, establishment of dairy product transportation and cold chain facilities, private veterinary clinics and dairy marketing outlets/ dairy parlours. The State-wise amount of subsidy disbursed during last three years and current financial year (upto 31.10.2019) under DEDS is at **Annexure – II**.

3. Dairy Processing and Infrastructure Development Fund (DIDF)

The scheme has been launched in December, 2017 by this Department with a total outlay of Rs. 10,881 Crore under which soft loan at subsidized interest rate of 6.5% is provided to milk cooperatives and producer companies. The State-wise loan disbursed by NDDB under DIDF is as under:
