- (a) Anganwadi Services is a universalised Scheme under Umbrella ICDS and is being implemented across the country including all districts of Bihar.
- (b) As on 30th September, 2019 out of total 1,04,090 operational Anganwadi Centres (AWCs) in the State of Bihar, 96,727 AWCs are reporting on ICDS-RRS portal. As per the data reported on ICDS-RRS portal, district-wise and category-wise number of beneficiaries covered under the scheme is given at <u>Annexure-I.</u>
- (c) The details of funds approved under APIP, funds released and funds utilized by the State of Bihar under Anganwadi Services Scheme during last three years is given at <u>Annexure-II</u>.
