Will the Minister of AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) be pleased to state:

- (a) whether the Government has any proposal to set up compulsory wellness centres of Yoga and Naturopathy in all the Government hospitals in near future in the country;
- (b) if so, the details thereof, State/UTswise and particularly in NCT of Delhi or NCR;
- (c) if not, the reasons therefor; and
- (d) the details of implementation procedure and plan outlay for any such proposal in the near future?

ANSWER

THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI SHRIPAD YESSO NAIK)

(a) to (d): As public health is a State subject, setting up of wellness centres of Yoga and Naturopathy in all the Government hospitals in the country including NCT of Delhi comes under the purview of respective State/UT Governments. However, Central Government is implementing Centrally Sponsored Scheme of National AYUSH Mission (NAM) in the country including NCT of Delhi under which financial assistance is provided to States/UTs for setting up of Yoga Wellness Centres and Naturopathy Wellness Centres. The status of financial assistance provided for Yoga Wellness Centres and Naturopathy Wellness Centres, State/UT-wise including NCT of Delhi as per proposal received from them, is furnished at **Annexure**.

Since, NAM scheme is being implemented by State/UT Governments, therefore details of implementation procedure and plan outlay for Yoga Wellness Centres and Naturopathy Wellness Centres proposal are under the domain of respective State/UT Governments.
