#### 3209. MS. DIYA KUMARI

Will the Minister of ENVIRONMENT, FORESTS AND CLIMATE CHANGE be pleased to state:

- (a) the parameters considered by the Government to declare an area around a forest/sanctuary as Eco-Sensitive Zones;
- (b) whether the Government has received any recommendations from the State Governments to alter the said criteria, if so, the details thereof; and
- (c) the details of such ESZ declared by the Government as on date, State/UT-wise?

# MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI BABUL SUPRIYO)

- (a) and (b) The Wildlife Division of this Ministry has issued "Guidelines for Declaration of ESZ around National Parks and Wildlife Sanctuaries" in 2011 with consultations among the states/UTs. In general, the following parameters are considered for declaring Eco-sensitive Zones:
  - I. Details of the Protected Area (PA);
  - II. Proposed ESZ Area and Extent;
  - III. Available Biodiversity, Flora, Fauna in the Area;
  - IV. List of villages in ESZ;
  - V. Prohibited and Regulated Activities along with Promoted Activities; and
  - VI. Maps of the ESZ delineating the ESZ boundary
- (C) The Government as on 02.12.2019 has issued Final ESZ Notifications for 366 Protected Areas. The State/UT-wise list is annexed.
