FOREST RIGHT ACT REVOKED IN MIZORAM

3420. SHRIMATI PRATIMA MONDAL:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether it is true that Forest Right Act (FRA) was revoked in Mizoram dueto stoppage of fund by the Union Government; and
- (b) the funds allocated by the Government during the past three years and current year for FRA, State-wise?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFIARS (SMT. RENUKA SINGH SARUTA)

(a): - Mizoram Government has informed on 05.12.2019 that the Forest Right Act (FRA) was revoked in Mizoram due to stoppage of fund by the Union government and the notification for the revocation of FRA in Mizoram has not been issued yet.

The Project Appraisal Committee (PAC) held on 29.04.2015 had not approved proposal from the State amounting to Rs. 10 lakh for implementation of FRA in Mizoram as FRA issues in the State were already settled.
