(a): A statement indicating the State/ Union Territory (UT)-wise number of beneficiaries covered under the National Food Security Act, 2013 (NFSA) is at Annexure-I.

(b): The NFSA provides for coverage upto 75% of rural population and upto 50% of urban population for receiving highly subsidized foodgrains under Targeted Public Distribution System (TPDS), thus covering about two-thirds of the total population. Corresponding to the all India coverage of 75% and 50% in the rural and urban areas, State-wise coverage was determined by the then Planning Commission (now NITI Aayog) by using the NSSO Household Consumption Expenditure Survey data for 2011-12.

At present, against the intended coverage of 81.35 crore, about 80 crore beneficiaries are identified by the States/UTs under the Act.

(c): Food Subsidy under the NFSA is not allocated on the basis of States/UTs. A statement indicating funds released to States/UTs under NFSA, during the last two years is at Annexure-II.
