- (a) whether the Government provides financial assistance to the persons belonging to Scheduled Caste communities to set up and operate their own educational institutions for promoting education; and
- (b) if so, the details of the financial assistance released during each of the last three years and the current year, State-wise?

(a) & (b): This Ministry is implementing a Central Sector Scheme of Grants-in-Aid to Voluntary and Other Organisations working for Scheduled Castes, under which Grants-in-Aid is provided to Voluntary Organisations/NGOs/institutions like NSFDC and NSKFDC working for the welfare of scheduled Castes, for running school, Hostels and Skill development programs for Scheduled Castes.

The details of the financial assistance released to NGOs/VOs during each of the last three years and the current year, State wise is given as **Annexure**.
