Will the Minister of ELECTRONICS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) the amount of budget sanctioned for the Pradhan Mantri Gramin Digital Saksharta Abhiyaan in each of the last two financial years, State / UT-wise including Andhara Pradesh; and
- (b) the total number of people trained under this scheme during the last three years, State/UT-wise?

(a) and (b): The budget sanctioned for the Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA) Scheme during the FY 2017-18 and FY 2018-19 was Rs. 100 Crore and Rs. 438 Crore respectively, out of the total budget outlay of Rs. 2351.38 Crore for the Scheme.

As the above Scheme is funded as a Central Sector Scheme, hence, funds are not allocated to States and UTs. The State/UT-wise details of overall fund requirements based on their earmarked targets are given in the Annexure. The State/UT-wise number of candidates trained so far in last three years is also given at Annexure.
