PROMOTION/MODERNISATION OF KHADI INDUSTRY

3985. SHRIMATI DARSHANA VIKRAM JARDOSH: SHRI RAJESHBHAI CHUDASAMA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the steps taken by the Ministry in association with the various State Governments to promote Khadi textile and modernise the Khadi industry as on date, State-wise;
- (b) the steps taken by the Ministry to promote the export and exporters of Khadi Textiles, State-wise;
- (c) whether the sales, production and job opportunities have been declined in Khadi sector during the last three years;
- (d) if so, the details thereof for the last three years and the reasons therefor; and
- (e) the number of new institutes set up under Khadi and Village Industries Commission during the last three years in various States including in the State of Gujarat?

ANSWER

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NITIN GADKARI)

- (a): Ministry of Ministry of Micro, Small and Medium Enterprises (MSME), through Khadi and Village Industries Commission (KVIC) is implementing the following components/sub-components of 'Khadi and Gramodyog Vikas Yojana' (KGVY),to promote Khadi textile and modernize Khadi Industry in the country:
- (1) Rozgar Yukt Gaon (RYG) To give boost and generate employment opportunities in the villages through hand spun charkha, a new scheme 'Rozgar Yukt Gaon' has been launched with an objective to introduce enterprise-led model replacing subsidy-led model in 50 villages with a total cost of Rs. 41.00 crore for the years 2018-19 and 2019-20. As part of the scheme, the artisans will be provided with charkhas, looms, warping units, professional skills and administrative framework support to create 12500 direct and 5765 indirect totalling 18265 employment opportunities. Zone-wise distribution of Khadi Gaons is placed at **Annexure-I**.
- (2) <u>Khadi Reforms Development Programme</u> (KRDP) was launched in 2009-2010 with an aim to revitalize the Khadi sector with enhanced sustainability of Khadi, increased incomes and employment for spinners and weavers, increased artisans' welfare and to achieve synergy with village industries. An amount of Rs.585.46 crore has been released by the Ministry to KVIC during the period from February 2010 to 31.3.2019. State/UT-wise number of Khadi Institutions sanctioned Direct Reform Assistance (DRA) by KVIC under KRDP as on 30.11.2019 is placed at **Annexure-II**.

In addition to the above, Ministry is also implementing the 'Scheme of Fund for Regeneration of Traditional Industries' (**SFURTI**) for making Traditional Industries more productive, market driven and competitive by organizing the Traditional Industries and artisans into clusters. The Scheme envisages providing need-based assistance for setting up of Common Facility Centres (CFCs), product development, quality improvement, improved marketing, training and capacity building etc. Under this scheme, traditional industries clusters including Khadi related clusters are set up. State/UT-wise number of SFURTI Khadi clusters along with project costs as on 30.11.2019 is placed at **Annexure-III**.

(b): The export of Khadi & Village Industries (KVI) products is done by the KVI Institutions and units directly or through merchant exporters. Initiatives taken by the Government to promote the export and exporters of Khadi Textiles and the details of the countries to which Khadi products are exported along with the quantum of Khadi products exported during each of the last three years is placed at **Annexure-IV**. State-wise data is not maintained by the KVIC.

(c)&(d): No, Sir. Progress of Khadi, including Poly Vastra and Solar Vastra, during the last three years shows an increasing trend, which is as follows:

<u>Initiatives/steps taken by the Government to boost the sale of Khadi and to make Khadi an</u> international brand:

1. Assistance is provided under the MPDA Scheme to the eligible Khadi and Village Industries (KVI) Institutions for participation in International Exhibitions/Trade Fairs held in foreign countries in order to showcase KVI products to foreign countries, access international buyers and sellers and forge business alliances, etc.

The eligible items for such participation and the scale of assistance is as under:

ii)	Air Fare	For KVIs – 100% of the Economy Class air fare subject to a maximum of Rs.1.00 lakh or actual fare paid, whichever is lower (for one representative from each participating enterprise)

- 2. Participation in International Trade Fairs through ITPO, New Delhi where KVI products find wide exposure to International Trade Delegation, Importers, Overseas Buyers, Franchisees, Branded Merchandise Outlets, Retailers, Malls, and Shopping Centres etc.
- 3. Tie up arrangements
 - i) for bringing out innovative export quality product designs with NIFT.
 - ii) with premier export institutions like Directorate General of Foreign Trade (DGFT), Federation of Indian Export Organization (FIEO), CII and FICCI.
 - iii) with premier institutions like FIEO, World Trade Centre, ITPO, Trade PromotionCouncil of India etc., for invigorating business opportunities in the overseas market by conducting exhibitions and workshops for Khadi Institutions.Arranging training in Export Procedure and Documentation for Export Oriented Units (EOUs), Institutions and Entrepreneurs in the KVI Sector through these institutions.
- 4. A MoU was signed between KVIC and Aditya Birla Fashion & Retail Ltd. (ABFRL), Raymond and Arvind Mills for sale of Khadi fabric in country and abroad.

- 5. KVIC has applied to register "Khadi" as a word mark and "Khadi India" as a Trade mark in 27 classes for various products among 45 classes listed out in the IPR Act at National Level as well as has filed an online application for registering "Khadi" as a trade mark under International Bureau in European Union and other countries under 16 different class.
- 6. KVIC Exhibiting/Promoting Khadi products under activity of "Global Khadi" on the eve of celebration of 150th Birth Anniversary of Mahatma Gandhi and shipped the Khadi products to 46 Indian Embassies/Missions abroad.
- 7. The KVIC is also conducting Export workshops for the benefit of Khadi Institutions.
- 8. Government has issued Harmonized System (HS) code to categorize 11 Khadi products in export and separate tariff lines for these have been created. Definition of Khadi also been included in the supplementary notes of the Customs tariff, w.e.f. 1.11.2019 on tentative basis. HS code is a unique identity of product ID internationally accepted.
